

Samples from current production are tested in OEKO-TEX® institute laboratories. If the samples meet the criteria, a certificate is issued for one year and can be renewed each year after a re-testing.

Testing for harmful substances supports companies in ensuring a high level of human-ecological product safety.

Samples from current production are tested in OEKO-TEX® institute laboratories. If the samples meet the strict OEKO-TEX® criteria, a certificate is issued. The certificate is valid for one year and can be renewed each year after re-testing.

OEKO-TEX® STeP certification sets the highest standards for both social and environmental aspects of textile and leather production. This label is a sign of responsibility towards employees and the environment, and supports a company's journey towards more sustainable production.

Once production facilities have completed an online questionnaire on all six STeP modules. The data is analyzed by auditors then evaluated and validated at the facility. The manufacturer receives the certification and a detailed report including benchmark score.


